Consideration of an Ordinance of the Commission of Knox County, Tennessee to amend Article 2 and Article 3 of the Knox County Zoning Ordinance (Appendix A of the Knox County Code) to prohibit the conversion of billboards and other advertising signs to electronic message center signs in all zone districts (Ord. No. O-90-9-130, adopted 9-10-90, as amended) was before the Board of Commissioners on second reading.

No. O-90-9-130, adopted 9-10-90, as amended) with the following amendment: Delete Under Article 2, Section 2.20 delete mechanical. Exhibit A will read as follows:

Proposed Amendments to Knox County Zoning Ordinance
Prohibiting Conversions of Billboards and Other Advertising Signs in All Zone Districts
to
Electronic Advertising Signs

TO PROHIBIT THE CONSTRUCTION OF ELECTRONIC ADVERTISING SIGNS AND THE CONVERSION OF BILLBOARDS AND OTHER ADVERTISING SIGNS TO ELECTRONIC ADVERTISING SIGNS IN ALL ZONE DISTRICTS, THE FOLLOWING REVISIONS ARE NEEDED TO THE KNOX COUNTY ZONING ORDINANCE:

Deleted language is marked with strikethrough New language is underlined and bolded.

Amend Article 2, Section 2.20 by adding the following:

ADVERTISING SIGN, ELECTRONIC - An advertising sign utilizing electronic means to form or alter the announcement, direction, or advertisement appearing on the sign.

Amend Article 3, Section 3.90.16 as follows:

3.90.16 NON-CONFORMING OUTDOOR ADVERTISING SIGNS AND STRUCTURES

A. An owner of any advertising <u>sign</u>, or business sign, or <u>structure electronic</u> <u>advertising sign</u> legally existing at the time of the adoption of this amendment shall have the right to continue such non-conforming use.

- B. An owner of any electronic advertising sign legally existing at the time of the adoption of this amendment shall have until July 1, 2013, to register with the Knox County Codes Administration for purpose of ensuring to the owner the right to continue such non-conforming use.
- C. After the effective date of this ordinance, no person shall construct any electronic advertising sign or convert any existing advertising sign to an electronic advertising sign.
- D. After July 1, 2013, any non-conforming electronic advertising sign not registered shall be considered an illegal sign. The Codes Administrator shall notify or make reasonable effort to notify the owner of the sign of such condition. If after thirty (30) days of such notification the sign has not been removed by the owner, the County, its officials, or its employees shall have the authority to enter on the private property on which the sign is located to remove such sign and/or institute appropriate action to have the sign removed. The County is further authorized to place a lien, in the amount of the removal cost, against the property upon which the illegal non-conforming sign is located.
