WHEREAS, it is the intention of the Commission of Knox County, Tennessee (the "County") to provide for the funding for improvements to parks and recreation facilities and improvements to public buildings, including legal, fiscal, administrative, architectural and engineering costs incident thereto; and

WHEREAS, it is the intention of the Commission of the County to pay all or a portion of the costs associated with said activities by the sale of bonds or other debt obligations of the County; and

WHEREAS, it is anticipated that it will be necessary to make expenditures in payment of said costs prior to the issuance of said bonds or debt obligations; and

WHEREAS, the Commission of the County wishes to state its intentions with respect to reimbursements for said expenditures in accordance with the requirements of final regulations applicable thereto promulgated by the United States Department of the Treasury.

NOW, THEREFORE BE IT RESOLVED BY THE COMMISSION OF KNOX COUNTY AS FOLLOWS:

- Section 1. It is reasonably expected that the County will reimburse itself for certain expenditures made by the County in connection with the activities hereinabove described. The County intends to reimburse such expenditures by issuing its bonds or other debt obligations. The expenditures made prior to the issuance of said bonds or other debt obligations are expected to be paid from the General Fund or other appropriate fund of the County, and reimbursement shall be made to the General Fund or other appropriate fund.
- Section 2. The maximum principal amount of bonds or other debt obligations expected to be issued to finance the activities hereinabove described is \$10,514,141.
- Section 3. This resolution shall be placed in the minutes of the Commission and shall be made available for inspection by the general public at the office of the County Clerk.
- <u>Section 4</u>. It is the County's reasonable expectation that it will reimburse the original expenditures from the proceeds of bonds or other debt obligations.
- Section 5. This resolution constitutes a declaration of official intent under Treas. Reg. § 1.150-2.
- <u>Section 6.</u> All resolutions or parts of resolutions in conflict herewith are hereby repealed.
- Section 7. If any notifications are to be made to effectuate this resolution, then the County Clerk is hereby requested to forward a copy of this resolution to the proper authority.
- <u>Section 8.</u> This resolution shall take effect from and after its adoption, as provided by the Charter of Knox County, Tennessee, the public welfare requiring it.
