"It is acknowledged that any exemptions are reviewed by the director should not be construed as an opportunity to circumvent the letter and spirit of the Knox County Stormwater Ordinance. It is also not the intent of Knox County Government to place undue and unreasonable hardships on individual business and property owners."

5. In Section 4.5.5 (c):

"Reinforced concrete pipe shall be used for pipes and/or cross drains that are:"

Should be changed to

"Reinforced concrete pipe shall be used for pipes and/or cross drains that meet any of the following four conditions:"

6. In Section 16 (b), the following should be added following the first sentence:

"The minimum penalty for fines associated with land development activities shall be one thousand dollars (\$1,000)."

7. In Section 16 (e), the first sentence should be changed to read:

"Notice shall be served upon the alleged violator either by personal service or certified mail."

8. In Section 16 (e), the second sentence should be changed to read: "Upon receipt of notice from Knox County of the assessment of a civil penalty and/or damages, the alleged violator may request a meeting with the Director of Engineering and Public Works."

This criterion shall be applied to both closed conduit and open channel components. Minor systems that discharge to sinkholes must be designed to safely carry the 100-year frequency storm event.
- (b) All drainage systems shall be designed to insure that no habitable flood elevations are flooded for the 100-year frequency storm, and that no structures are located within this vertical projection of the 10-year floodplain line (i.e., located within the 10-year floodplain). Pipes and culverts designed for a 100-year storm shall be constructed of either corrugated metal (CMP), high density polyethylene (HDPE), polyvinyl chloride (PVC), or reinforced concrete (RCP) pipe (class 4).
- (c) Cross drains or pipes that carry public water under pavements surfaces, and any pipe, culvert, or drainage system dedicated to Knox County, a private individual or a Homeowners' Association, whether inside or outside the right-of-way, can be constructed or reinforced concrete (RCP), high-density polyethylene (HDPE), polyvinyl chloride (PVC) or corrugated metal (CMP). It shall be the

responsibility of the property owner to provide all necessary design, date, and installation details for construction to ensure failure will not occur, and prevent flooding or potential property damage on adjacent properties or right-of-ways.
