4. Discuss why any objectives were not reached or why implementation is behind schedule:

Knox County is slightly behind on our action item goals due to several factors, one of which is the Covid-19 situation. Knox County has taken a precautionary approach to undertaking new projects due to the uncertainty of expected revenue sources. Progress has been made as Knox County has allocated a significant amount of funds to assist in alleviating flooding situations in several parts of the county. Knox County has not started or has temporarily decided to place some potential action items on hold until expected revenues have stabilized. Knox County will continue to apply for possible grants to assist in these endeavors.

5. What are the recommendations for new projects or revised recommendations?

Knox County will continue to apply for grant opportunities and may reexamine the possibility of committing even more local funds to assist in accomplishing these goals.

County-1	Secure funding for a buyout of flood prone properties that experience repetitive flooding.	Knox County is considering one acquisition/demolition project for this fiscal year and is considering doing several acquisition/demolition projects next year and in subsequent years. In addition, Knox County is currently working with a consultant to develop a plan to mitigate several potential repetitive flooding areas. \$2,650,000 was placed in fiscal year 2020-2021 for floodplain mitigation projects.
County-2	Continue participation in the National Flood Insurance Program (NFIP)	Continue to actively participate in NFIP and CRS Programs
County-3	Secure funding for roadway improvement projects that would protect roadways from repetitive flooding.	Knox County has budgeted \$1,600,000.00 in FY 2020-2021 to begin Cedar Bluff Road-Fox Lonas Road Project to lessen flooding issues on these roads.
County-4	Secure funding for construction of regional detention basins.	This item is part of the Cedar Bluff Road- Fox Lonas Road Project that is budgeted to begin in FY 2020-2021.
County-5	Secure funding for uninterrupted power supply (UPS) battery-backup systems for traffic signals on critical roadway segments.	No Change – Budgetary constraints
MultiJurisdictional-1 Knox County, City of Knoxville, & Town of Farragut	Protect or relocate flood prone critical facilities.	No Change – Budgetary constraints
